Anyone wishing to store a camper or camping vehicle or any equipment or belongings, of any kind (including screen houses or platforms) which precludes the use of the site by others, at Bowdish Lake Camping Area, from season closing until the opening day of the next season, or any term therein, may do so only if this form, required by the Town of Glocester, is completed and returned and a storage fee is paid in full, **both to occur on or before October 31st** and only with the understanding that Bowdish Lake Camping Area, Inc. or its owners are in no way responsible for any damage and/or theft, of any kind, should such occur, and provided the conditions herein are met.

Trailers may be stored on site for \$300.00, or in the Safari Field for a reduced fee of \$100.00. Campers must ask the Office for an approved location in the Field in advance.

Anyone who leaves their trailer or belongings on the site over sixty days without paying storage shall lose site privileges and under state law possible disposal.

Starting 2020-2021, we are charging for boat storage and golf cart storage.

☐ \$100.00 if boat and trailer are stored on site. ☐ \$50.00 for golf carts stored on site.

We have installed a gate at the tennis court and now offer locked Winter storage. There is limited amount of locked storage space so plan ahead.

☐ \$200.00 for boat on trailer in locked storage. ☐ \$100.00 for golf cart in locked storage.

☐ \$300.00 for camper stored on site. ☐ \$100.00 for trailer stored in field.

CONDITIONS

☐ \$100.00 items only (no trailer, boat, cart, etc.)

Site must be left clean. No nails in trees; no ropes in trees; no loose articles left on the site; no signs left up; no ornaments, etc. All boats must be taken away from our entire waterfront. Boats may be stored on your site only if your trailer is stored, and fees paid.

Our intent is to minimize any damage which could occur to your property in winter storms.
